If the State Government changes any of these holidays, the changed date only will be observed as a Closed Holiday for Central Government Offices also. But, if the State Government sanctions any additional holiday(s) in connection with the above occasions, the date(s) of such additional holiday(s) will be observed as Restricted Holiday(s) only for Central Government offices. If the change of date of any of the above occasions is notified at very short notice, announcement through TV/AIR/Newspaper can be taken as authority for such change.
